Welcome Letter



Dear Ohio FBLA Advisers & Chapter Leaders.

Last February Ohio FBLA was one of the few state chapters able to facilitate a state conference before the pandemic altered life as we knew it. We had reimagined our SLC, hosting approximately 350 advisers, students, and guests at the Crowne Plaza – Columbus North-Worthington. Our attendees participated in workshops, networked, and earned top honors on stage at the Closing Session. Students also participated in the state competitive events program including, open events which were a new addition. Notable guests included the Ohio State Superintendent of Schools, Paulo DeMaria and a keynote speech from Steve Flannery of Avery-Dennison. In addition, over 15 colleges, universities, and partners exhibited in our first annual college and career fair. Finally, we unveiled two new events for students to participate in as part of their SLC experience: The Leadership Expo & Conference Social (replacing the dance).

Then in May, due to the COVID-19 global pandemic, the national association decided to convert the NLC into a virtual format: renamed the National Leadership Experience (NLE). On June 29 – July 1, Ohio FBLA sent 51 competitors to the virtual National Leadership Experience in San Antonio, TX. Ohio FBLA also ran state president, Rhea Mehta, for North Central Region VP. Nell Rapport (Harvey) and Gaven Nash (Celina) were recognized as outstanding local chapter adviser and who's who respectively. The state winners our outlined below:

- Broadcast Journalism 10th Place
- Introduction to Financial Math 7th Place

As the 2020-2021 school year began in-person, virtually or as a hybrid of the two we sought out and reviewed feedback from our advisers to determine the best course of action for this year's state program. As uncertainty related to the pandemic remains we have realized that once again we will need to reimagine, temporarily, our upcoming State Leadership Conference which will be held virtually this year. Important Information (Overview)

Membership Dues

FBLA Dues: \$13 (\$6 national and \$7 state) ML Dues: \$11 (\$6 national and \$5 state)

(Local dues are at the discretion of the local chapter)

NOTE: A chapter must have a separate Middle-Level charter to be able to pay ML dues for Grades 5-8 members (Grade 9 for members in specified junior high building). Members must be part of a ML chapter to compete at the ML SLC.

Paying Dues

Pay or Renew dues online at www.fbla-pbl.org. If a credit card is not used at the time members are entered, an invoice will be sent to the school for payment with a check. Paid state dues must be on record with the national office no later than January 29th to be eligible to compete at both the ML and HS State Leadership Conference and/or run for state office. All outstanding invoices must be PAID to the national office by March 1 for students to compete at the National Leadership Conference.

New or Reactivating Chapters

If you are a new chapter or need to reactivate your chapter or know of a chapter interested in chartering or reactivating, download the Chapter Organization Packet (COP) on the national Web site at www.fbla-pbl.org. Request a Chapter Organization Packet by clicking on START A CHAPTER, and you are on your way! The fee to charter or reactivate is \$20.

NOTE: Charter and Reactivation fees for the 2020-2021 year have been waived by the National Office! Contact Eric McGarvey at emcgarvey@ohiofbla.org to get started!



HS Chapter Recognition

Jump start your HS chapter with Non-stop November and Action Awareness in January and your chapter will be well on its way for Outstanding Chapter and Gold Seal Awards (National Awards), as well as Chapter of the Year (State Award). Start early to be recognized at SLC and/or NLC for these awards.

HS Individual Recognition

The easiest way for your HS members to become **active** members is to get them working on individual recognition. Get them started immediately on the Business Achievement Awards https://www.fbla-pbl.org/fbla/programs/education/baa/, Membership Madness, Membership Mania, and Community Service Awards https://www.fbla-pbl.org/fbla/programs/recognition-awards/csa/. The Business Achievement Awards continue all four years so if members did not finish the Future level last year, they can pick up where they left off and finish this year!

Any hours of community service count for recognition for the **Community Service Awards**. It does not have to be only FBLA community service. This award follows the member throughout his or her years of membership. Therefore, members can finish the 50 hours (called Community) this year and continue with the 200 hours (called Service) next year. The final level is 500 hours called Achievement.

There are not many high school students that are not doing some kind of community service. Let FBLA give them some recognition at SLC. For more information on Chapter and Individual Recognition awards, see *Chapter Management Handbook* in the Recruitment, Retention, and Recognition section.

Similar to BAA for high school, ML members can now earn Bronze, Silver, and Gold through **LEAD**. The activities in each level focus on Leadership, Education, and Community Service. The list of activities for each of the LEAD levels should be available on the national website by September 1. The ML **Young Leader Award** will recognize members with extraordinary commitment to leadership and community service. Members must have achieved at least the LEAD Silver level to be eligible for this award. Each state may nominate one member to represent them at NLC for this award. Ohio FBLA will recognize community service hours for ML members much like the high school awards. Conference name badges are part of this dress code and must be worn for all conference functions.

- · Collared dress shirt and neck or bow tie
- Dress shoes/dress boots

UNACCEPTABLE

- Jewelry in visible body piercing, other than ears
- · Denim or flannel clothing of any kind
- Shorts
- · Athletic clothing
- Leggings or graphic designed hosiery/tights
- Skintight or revealing clothing, including tank tops, spaghetti straps, and mini/short skirts or dresses
- Swimwear
- Flip flops or casual sandals
- Athletic shoes
- · Industrial work shoes
- · Hiking boots
- · Boat shoes
- · Any canvas or fabric shoes
- Hats
- Clothing with printing that is suggestive, obscene, or promotes illegal substances

No dress code can cover all contingencies, so FBLA-PBL members must use a certain amount of judgment in their choice of clothing to wear.

Members who experience uncertainty about unacceptable attire should ask their local or state adviser.
